1. The Government of Nepal has applied a loan from the Asian Development Bank (ADB) towards the cost of South Asia Subregional Economic Cooperation Power System Expansion Project. Part of the loan will be used for payments under the contract named above. No nationality restrictions apply, other than any restriction arising from ITB 4.7.
2. The Nepal Electricity Authority ("the Employer") invites sealed bids from eligible bidders for the construction and completion of Design, Supply, Installation and Commissioning of Dhalkebar – Mujeliya 33kV DC Line Conductor Upgrading, ("the Facilities").
3. International Competitive Bidding (ICB) will be conducted in accordance with ADB's Single Stage, Two Envelope Bidding Procedure and is open to all Bidders without nationality restrictions.
4. Bidders shall have minimum average annual turnover of US\$ 4.8 Million. Bidders are required to have satisfactory experience in at least 2 (Two) contracts with design, supply, installation and commissioning of HTLS Conductor within the last 7 (Seven) years, with a value of at least US\$ 2.4 Million each.
