- The Government of Nepal has applied for financing from the Asian Development Bank (ADB) towards the cost of **Disaster Resilience of Schools Project**. Part of this financing will be used for payments under the contracts named above. Bidding is open to bidders from eligible source countries of ADB.
- The **Central Level Project Implementation Unit (Education), National Reconstruction Authority (NRA)** (the "Employer") invites sealed bids from eligible bidders or joint ventures for the **Construction of School buildings, Toilet and Water Supply facilities including site development works in 12 (Twelve) schools in Dolakha District**. Construction period is 18 months after contract signing date.

 - Pay a non-refundable fee of NPR 20,000 or USD 200 towards the cost of the Bidding Document.
 - Bidder who wish to receive the bidding document by courier shall pay an additional amount of NPR. 25,000 or USD 250 for overseas delivery. No liability will be accepted for any loss or late delivery.
