Invitation for Bids for the **Enhancement of Distribution Network**

1. The Government of Nepal [GoN] has allocated funds towards the cost of *Enhancement of Distribution Network* and intends to apply part of the funds to cover eligible payments under the *Contract for Enhancement of Distribution Network*. Bidding is open to all eligible Nepalese and Foreign Bidders.
2. **Lumbini Development Trust** invites sealed bids or electronic bids from eligible bidders for the *Enhancement of Distribution Network* under International Competitive Bidding – Two Envelope Bidding procedures. Only eligible bidders with the following key qualifications should participate in this bidding:
Minimum Average Annual Construction Turnover of the best 3 years within the last 5 years: **NRs. 243,000,000.00**
Minimum Work experience of similar size and nature: Two Project with project cost NRs. 120,000,000.00.
3. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of **Lumbini Development Trust, Sacred Garden, Rupandehi, Lumbini, Nepal** or may visit LDT website <http://idtprocurement.org.np>.
4. A complete set of Bidding Documents may be purchased from the office **Lumbini Development Trust, Sacred Garden, Rupandehi, Lumbini, Nepal** by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of **NRs. 20,000.00 (Twenty Thousand)** till **45th days from notice publish**.

Or

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from IDT's Web Site www.idtprocurement.org.np. Bidders, submitting their bid electronically, should deposit the cost (as specified above) of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 5. Pre-bid meeting shall be held at **Lumbini Development Trust, Sacred Garden, Rupandehi, Lumbini, Nepal** at **12.00 Hrs of 30th day from first date of bid invitation notice publish**.
6. Sealed or electronic bids must be submitted to the office **Lumbini Development Trust, Sacred Garden, Rupandehi, Lumbini, Nepal** by hand/courier or through LDT website <http://idtprocurement.org.np> on or before **12 Hrs** on **46th day from the first date of bid invitation notice publish**. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **14.00 Hrs of 46th day from the first date of bid invitation notice publish** at the office of **Lumbini Development Trust, Sacred Garden, Rupandehi, Lumbini, Nepal**. Bids must be valid for a period of **120 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs. 6,865,000.00, US\$ 65,800.00**, which shall be valid for 30 days beyond the validity period of the bid.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
