Invitation for Bids

- Office of District Coordination Committee, Nawalparasi has allocated funds towards the cost of projects mentioned below and intends to apply part of the funds to cover eligible payments under the contract for the projects mentioned below. Bidding is open to all eligible Nepalese and Foreign Bidders.
- Interested eligible bidders may obtain further information from District Technical Office, Nawalparasi and inspect the Bidding Documents during office hours or may visit E-procurement section of PPMO Web Site <http://www.bolpatra.gov.np>
- A complete set of bidding documents may be purchased by the interested bidders upon submission of a written application, attaching copies of the bidders registration, VAT registration and Tax Clearance Certificate/Tax return submission evidence for the F/Y 072/073 to the District Coordination Committee, Nawalparasi and upon payment of a non-refundable fee or its equivalent in freely convertible currency as shown in the table below. Bidding documents can be purchased within the office hrs up to **2nd June, 2017**.
- For the purpose of Bidders who choose to submit their bid electronically through E-procurement section of PPMO Web Site <http://www.bolpatra.gov.np>, the Bidders may either purchase the hard copy of bidding documents or may choose to download the necessary part of bidding documents, prepare their bids and submit their electronic bids as specified in the Instructions to Bidders. In case the Bidder chooses to download and submit bid electronically, the Bidder shall be required to deposit the cost of bidding document (as specified in the table below) in the DDC's Rajaswa (revenue) account either by direct deposit or by tele-transfer of deposit in the DCC account for the purchase the bids as specified below and electronic scanned copy (PDF format) of the Bank deposit voucher or Tele-transfer certificate shall also be submitted along with the electronic bid files.

- Bids must be delivered to the District Coordination Committee, Nawalparasi on or before **12:00 hrs of 4th June, 2017**. Alternatively, bidders may submit their bid electronically through E-procurement section of PPMO Web Site <http://www.bolpatra.gov.np> as specified in the Instruction to Bidders. Late bids will be rejected. Bids will be opened physically and electronically at **13:00 hrs of 4th June, 2017** in the presence of the bidders' representatives who choose to attend at the District Coordination Committee, Nawalparasi.
- All bids shall be accompanied by a valid bid security of an amount as shown in the table below in local currency or an equivalent amount in a freely convertible currency. The bid security guarantee shall confirm to the standard format as specified in the bid document. The bid security guarantee issued by only the commercial bank approved by Nepal Rastraya Bank shall be accepted by the employer.
- Bids shall be valid for a period of 90 days after the deadline for bid submission date. Bid security shall remain valid up to 120 days after the deadline for bid submission.
- Pre-bid meeting will be held in the Office of District Coordination Committee, Nawalparasi at **14:00 hrs on 28th May, 2017**. Detail Information about submission process of bid electronically (e-submission) shall be provided to all interested bidders who choose to attend this pre-bid meeting.
- The District Coordination Committee, Nawalparasi reserves right to accept or reject any or all bids or annul the bidding process and reject all bids without assigning any reason, whatsoever.
- If the specified date for pre-bid meeting, last date of bid document purchasing and submission/opening falls on a Government holiday then the same time on the next working day shall be considered for such events. However, the last date for bid submission and opening shall be the next working day after the last date of bid purchasing. In such case the validity of bid security shall be considered from already specified last date for bid submission.
- Any intimidation, collusion and cartelling during bidding process shall be punishable by law.
