3. All bidders shall submit their bid electronically only. Electronic bid must be submitted through PPMO' e-GP system www.bolpatra.gov.np/egg on or before 12:00 Noon on **29 March 2018**. Details electronic bid submission procedure is as per e-GP directives of PPMO.

9. Bids shall be opened electronically after the bid submission in the presence of Bidder's representatives who choose to attend on **29 March 2018** at 13:00 hrs. at the office of DDC's Central Office, Lainchaur, Kathmandu.
10. Pre-bid meeting will be held on **15 March 2018** at 12:00 noon at DDC's Central Office, Lainchaur, Kathmandu.

If the specified date of pre-bid meeting, last date of bid documents purchasing and submission/ opening falls on Government holiday then the same time on the next working day shall be considered for such events. However, the last date of bid submission and opening shall be the next working day after the last date of bid purchasing. In such case the validity of bid security shall be considered from already specified last date of bid submission.
