For the purpose of Bidders submitting their bids electronically through Nepal Government's Centralized eprocurement portal <http://www.bolpatra.gov.np>, the Bidders may either purchase the hard copy of Bidding Documents or may choose to download the necessary part of Bidding Documents, prepare their bids and submit their electronic bids as specified in the Instruction to Bidders. The documents submitted after the specified time will not be accepted.

Bids shall be opened electronically after the bid submission in the presence of Bidder's representatives who choose to attend on 13th, November, 2018 at 1:00 pm. at the office of Department of Local Infrastructure (DoLI), Local Bridge Section, Shreemahal, Pulchowk, Lalitpur. Bid and Bid security must be valid for a period as mentioned in the table below.
