4. Electronic sealed quotation must be submitted to the Department of Health Services, Logistics Management Division, Teku, Kathmandu, Nepal through www.bolpatra.gov.np/egp on or before **12:00 Hour on 15 April 2018**.

Sealed quotation shall be opened in presence of Bidders' representatives who choose to attend on **13:00 Hour on 15 April 2018** at the office of Department of Health Services, Logistics Management Division, Teku, Kathmandu, Nepal. Sealed quotation must be valid for a period of 45 days after the day of sealed quotation opening and must be accompanied by bid security, amounting **NPR. 55,000.00**. The Bid Security shall be in the name of the Bidder and in the case of a Bid Security issued by a foreign bank, the same shall be counter-guaranteed by a Class "A" Commercial Bank in Nepal. The Bid Security must be valid for thirty (30) days beyond the bid validity period (i.e. **29 June, 2018**).
6. If the last date of submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
7. In the case of discrepancies or error in documents, notice or any other document, the DOHS reserves the right to amend and correct at any time.
