- The ministry of Health National Centre of AIDS and STD Control (NCASC), Teku, Kathmandu now invites sealed bids from eligible and qualified bidders for the Procurement of Anti Retro Viral Drugs to be delivered at National Centre for AIDS and STD Control (NCASC), Teku, Kathmandu.
A bidder may bid for one or more slices. Bidders bidding for more than one slice will so indicate in their bid form, together with a statement regarding discount/cross discount if any. Bidders shall quote for all the complete quantity of quoted slice(s). Evaluation will be conducted for each slice, with the final award being determined based on the combination that is of least cost to the Purchaser.
- Bidding will be conducted through the International Competitive Bidding (ICB) a procedure specified in the Public Procurement Act of Nepal and is open to all bidders from Eligible Source Countries as defined in the bidding document.
- Interested eligible bidders may obtain further information and inspect the Bidding Documents from the National Centre for AIDS and STD Control (NCASC), Teku, Kathmandu on GoN official working days between 10:00 to 17:00 hours (Nepal Time) within **45 days** from 1st day of publication (i.e. **2018/02/21 to 2018/04/06** or, at their own convenience, on the NCASC website (www.ncasc.gov.np).
- A complete set of Bidding Documents in English may be downloaded from the PPMO website or NCASC website or be purchased by interested bidders from **2018/02/21 to 2018/04/06** on the submission of a written application to the address below and upon payment of a non-refundable fee of NPR 5,000.00 or equivalent convertible currency. The method of payment will be in the form of cash deposit certificate in **Account No. 1700203000000 of Rastriya Banijya Bank, Teku Branch in the name of treasury office Kathmandu**. Foreign Bidders may also pay through a bank draft in favour of the National Centre for AIDS and STD Control (NCASC), or may receive the (numbered) Bidding Documents from the NCASC against submission of Cash Payment voucher at above mentioned bank account.
If requested in writing and on payment of an additional non-refundable fee of **NPR 6,000.00 or equivalent convertible currency** per set, documents shall be sent through a reliable courier service. The NCASC, however, will not be responsible for any delay or non-delivery of the documents so sent.
- Eligible bidder can submit their bids either electronically or manually. Both option are opened.
- Interested bidders must first register on the PPMO e-GP portal to access the documents and choose the electronic bidding procedure.
- For the purpose who choose to submit their bid electronically through e-procurement section of PPMO website: <http://www.bolpatra.gov.np>, the bidders may either purchase the hard copy of bidding documents or may choose to download the necessary part of bidding documents, prepare their bids and submit their electronic bids as specified in the Instructions to Bidders. In case of bidder who choose to download and submit bid electronically, the bidder shall be required to deposit the cost of bidding document as specified above in the above mentioned Account No. of NCASC at Rastriya Banijya Bank, Teku Branch and electronic scanned copy (pdf format) of the Bank deposit voucher/tele transfer receipt shall also be submitted along with the electronic bid files.
- Sealed Bids must be delivered to the address below at or before **12:00 hours** (Nepal Time) on 2018/04/08. Alternatively, bidders may submit their bid electronically through e-procurement section in PPMO website: <http://www.bolpatra.gov.np>, before the above deadline and as specified in the Instructions to Bidders. Documents received after this deadline shall not be accepted.
- Bids must be valid for 90 days after the date of bid opening and must be accompanied by Bid Security not less than the amounts mentioned on the table or the equivalent in a freely convertible foreign currency. The Bid Security shall be in the name of the Bidder and in the case of a Bid Security issued by a foreign bank, the same shall be counter-guaranteed by a Class "A" Commercial Bank in Nepal. The Bid Security must be valid for at least thirty (30) days beyond the bid validity period (**2018/08/06**). Bids will be opened in the presence of the bidders' representatives, who choose to attend in person, at the address below at 13:00 hours (Nepal Time) on 2018/04/08.
- If the specified date for submission and opening of the bid falls on a government holiday, then the same time of the next working day shall be considered for such events. The bid validity and validity of the bid security remain unchanged unless amended by another notice.
- A pre-bid meeting will be arranged at following address on **2018/03/20** at 11:00 AM. Interested bidders are requested to attend on the meeting.
- In case of discrepancies or error in bid documents, bid notice or any other document, the NCASC reserves the right to amend and correct at any time.
- NCASC reserves the right to accept or reject wholly or partly or all bids without assigning any reason whatsoever.
- The Public Procurement Act 2063(PPA2063) and Public Procurement Rules 2064(PPR2064) shall be used for the Provision of any dispute resolutions.
