

Invitation of Bids for Supply and Delivery of Vehicle

1. The Distribution and Consumer Services Directorate, NEA invites sealed bids from eligible bidders for:
Package 1: ICB/DCSD-073/74-15/01: Supply and Delivery of Double Cab Pick-Up Truck
Package 2: ICB/DCSD-073/74-15/02: Supply and Delivery of General Purpose Truck
Package 3: ICB/DCSD-073/74-15/03: Supply and Delivery of Crane Truck
2. The mode of procurement is International Competitive Bidding procedures.
3. Eligible Bidders may obtain further information and inspect the bidding documents at the office below.
4. The bidders who choose to submit their bid electronically are requested to visit the e-procurement section of NEA website <http://www.e-nea.org.np>.
5. Bidding documents may be purchased on or before **June 13, 2017** (during office hours) from the below office by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of **Nepali Rupees 20,000.00** (or equivalent amount in US\$) for Double Cab Pick-Up Truck, **Nepali Rupees 5,000.00** (or equivalent amount in US\$) for General Purpose Truck and **Nepali Rupees 15,000.00** (or equivalent amount in US\$) for Crane Truck in form of bank receipt for fee deposited in NEA Current Account **1206101/001-001-524** at **Nepal Rastra Bank, Thapathali, Kathmandu**. If so requested, the Bidding Documents can also be sent by post/courier services upon payment of additional fee of NRs. 10,000 or US\$ 100 each. However, the Purchaser will not be responsible for delay or non-delivery of the documents so sent.
6. Sealed Bids must be submitted to the below office on or before **12.00 hrs. on June 14, 2017**. Documents received after this deadline shall not be accepted.
7. Bids shall be opened in the presence of Bidders' representatives who choose to attend the bid opening at **14:00 hrs. on June 14, 2017** at the below office. Bids must be valid for a period of 120 days counting from the day of bid opening and must be accompanied by bid security, amounting to **NRs. 4.5 Million, NRs. 0.75 Million & NRs. 1.85 Million** (or equivalent amount in US\$) for **Double Cab Pick-Up Truck, General Purpose Truck & Crane Truck respectively**, which shall be valid for minimum 30 days beyond the bid validity period.
8. In the comparison of Bids, Domestic Preference Scheme will be applied in accordance with the provisions stipulated in the instruction to Bidders.
9. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
10. The Purchaser reserves the right to accept or reject any Bid, and to annul the bidding process and reject all Bids at any time prior to Contract award, without thereby incurring any liability to the Bidders.
