Ministry of Health and Population, Department of Health Services (DoHS), Logistics Management Division (LMD), Teku, Kathmandu re-invites electronic bids from eligible bidders for the Procurement of **Td Vaccine (WHO-PQ) 10 dose -178,650 vial** to be delivered at the Central Vaccine Store, Teku, Kathmandu under international competitive bidding.

3. Bidding documents is available online and can be download from e-GP system: www.bolpatra.gov.np/egp. Interested bidders shall register in the e-GP system and deposit the cost of bidding document **NPR. 3,000.00** in the following bank.

4. Electronic bids must be submitted to the Department of Health Services, Logistics Management Division, Teku, Kathmandu, Nepal through www.bolpatra.gov.np/egp on or before **12:00 Hour on 23 April 2018**.
5. Bids shall be opened in presence of Bidders' representatives who choose to attend on **13:00 Hour on 23 April 2018** at the office of Department of Health Services, Logistics Management Division, Teku, Kathmandu, Nepal. Bids must be valid for a period of 90 days counting after the day of bid opening and must be accompanied by bid security, amounting to a minimum of **NPR. 450,000.00** or the equivalent in a freely convertible foreign currency. The Bid Security shall be in the name of the Bidder and in the case of a Bid Security issued by a foreign bank, the same shall be counter-guaranteed by a Class "A" Commercial Bank in Nepal. The Bid Security must be valid for thirty (30) days beyond the bid validity period (**i.e. 21 August, 2018**).
6. If the last date of submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
7. In the case of discrepancies or error in bid documents, bid notice or any other document, the DOHS reserves the right to amend and correct at any time.
8. DOHS reserves the right to accept or reject wholly or partly or all bids without assigning any reason whatsoever.
