5. Three sets of sealed Bid documents (One original + Two copies) as per ITB 22.1 must be submitted to the office of Udayapur Cement Industries Ltd., Jaljale, Udayapur as below: on or before 14:00 PM on [2018-02-01 (2074 /10/18)] Documents received after this deadline shall not be accepted.
5. Bids shall be opened in the presence of Bidders' representatives who choose to attend on 15:00 PM on [2018-02-01 (2074 /10/18)] at the office of Udayapur Cement Industries Ltd., Jaljale, Udayapur. Bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by bid security, amounting to a minimum of 2.5% for Nepalese bidders and 5% for foreign bidders, of the quoted Bid amount (exclusive of VAT) valid up to 120 days from the date of bid opening.
7. The Bids shall be opened in the presence of bidders' representatives who choose to attend the Bid opening after 15:00 Hours on the same day [2018-02-01 (2074 /10/18)] at the Head office of UCIL, Jaljale, Udayapur, Nepal.
8. Bids must be valid for a period of 90 days counting from the day of Bid opening and must be accompanied by Bid security amounting 2.5% for the Nepalese Bidders and 5% for Non- Nepalese Bidders of the total prices quoted excluding VAT shall be in the form of bank guarantee issued by any "A" class Nepalese commercial bank which shall be valid for minimum 120 days beyond the bid validity period; bank voucher of the bid security deposited in the UCIL's bank account as specified in the bidding document should be furnished with the bids.
9. Bids not submitted or submitted after specified date and time shall be considered non-responsive and shall not be evaluated.
10. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
11. The Purchaser reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.
